	Visa application form. Visa application form filled out in detail(block letters) and signed by the applicant.
	Itinerary. Copy of round trip tickets or itinerary.
	Foreign Exchange or Credit Card copy. Applicant must provide Foreign Exchange or Credit Card copy
	Bank Statement. Copies of bank statements from the past 3 months.
absei	Employment Letter. A letter from your employer/school (on business letterhead, with contact details), stating that a leave of nee has been granted and that you will be returning to your current job. If you are self-employed, include a copy of your business
licens	se and tax return. If you are retired please submit proof of your retirement fund.
	Hotel Reservations. Copy of confirmed hotel reservations.
	Personal Letter. A personal letter from the applicant addressed to the Embassy of Morocco, explaining the purpose of the trip,

dates of travel, cities to be visited, and place of accommodation.
